This investment is in line with DLMI's long-term plans of improving its manufacturing capabilities to keep up with the demand for its products and with new consumer trends which will strengthen its ability to provide the goodness and nutritional value of milk to its customers.

2. FACILITIES TO BE CONSTRUCTED

The facilities which will be constructed on the Lands will include manufacturing and warehousing facilities, support facilities and office facilities (collectively, "New Facilities").
